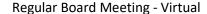
Expiring Advocacy Resolutions

G. Education Issues and E-Scan

Overview of Minister/Partners Conference Call – Covid focused

President Rai provided a high-level report of the intention of these meetings, and general perspectives that are presented, omitting specifics that may be considered confidential. She also reassured the Board that she represents ASCA clearly, even when her comments may be critical or in contradiction to what partners may be stating.

President Rai highlighted the enhanced contact tracing that AHS and the Education Minister have announced should now be taking place with respect to school cases of Covid-19, and explained the process used to arrive at the shift of language/terminology used to report on 'inschool' cases of Covid-19. She also provided her understanding of what GoA/AHS has communicated as their criteria for reporting confirmed cases on the Covid-19 school status map.

Return to in-class schooling (Jan 11/21):

President Rai shared that she has received a fairly balanced representation of opinions with respect to the return in in-class schooling on January 11, 2021. Needing to represent all families, she has advocated that measures preventing community transfer of Covid-19 enable students that need to be in school to be there.

Items identified by Directors:

Director Scott commented that Elk Island Public went back to in-school learning on January 6, and at a recent CoSC meeting there were concerns expressed about young (8 yrs. old) children needing to be left alone at home for online learning prior to the winter break. She also questions if the flexibility and discretion being applied to when teachers are 'in-class' for online learning could or will result in an audit of the 'need' to have teachers at the level currently expected/utilized in 'normal' times, in the future.

Director Surgenor Gaglione agrees that reducing the community spread is the most important factor in keeping students and teachers safe through in-class learning. Elk Island Public parents have also expressed concern about the lack of access to technology devices suitable for participating in online learning, even if it's only for a few days. There have also been comments about the inequity of instruction for a short-term move to online learning. The Division's expectations in this regard are not being met. She also expressed concerns related to the shift in how assessments are being done, and the impacts on the students' futures. She wonders if, with the 4 months of data currently available, could an assessment be made with respect to the



spread threat in schools, and possibly tighten up the requirements of who needs to be isolated when there is a positive case?

Director Hobday observed that expectations, implementation and outcomes are too varied, not only across the province but even at Division, or school (Gr. 3 vs Gr. 6) levels.

Director Haggerty commented on the lack of consistency in the quality of teaching, length of 'inclass' expectations in the 'short-term' online learning environment, especially for the K-6 students who only had the one week in January, vs. the Jr and Sr High students who participated longer. He also expressed concerns about the potential for insufficient data for teachers to make accurate assessments with students bouncing back and forth between online and in-class learning. President Rai supported these comments by offering her observations that there are huge differences for students who are learning online by choice, vs. those who have been forced into online learning either by isolation requirements, or division/ministry requirements.

Other Directors provided personal experiences for their children and families and expressed concerns for other students and families across Alberta. In most cases, the situations were less than ideal, with a perceived lack of access to qualified teaching staff for the time students need them. Some divisions canceled exams, just giving staff and students a 2-day 'semester turnaround' break. Others persevered with exams.
