# **PRESIDENT'S ADDRESS**

"Good morning, everyone!

It is my pleasure to start the Annual General Meeting by presenting my President's report. I've been very fortunate to serve as your President for the past three years. I have enjoyed hearing of how school councils across the province are actively engaged in supporting and enhancing student learning in their schools and districts, and I am grateful to work with some truly incredible individuals.

2018 – 2019 has been a year as busy and intense as the AGM agenda before you today! Knowing how much business needs to be accomplished today, I am just going to touch briefly on some of the highlights in three key areas: Representation of our members – also known as Advocacy; Service and Support to our members; and Stewardship of the Association on behalf of our members. In the binders on your tables you will find reports that provide a great deal of details regarding what the Association and your Board have been working on this year.

# Representation/Advocacy:

Eighty-seven (87%) percent of the school councils able to be an ASCA Member have done so this past year. We have over 1330 Member School Councils, out of a possible estimated 1534, and are very pleased that a new school district – Prairie Rose School Division – joined all other Alberta public school districts this year in sponsoring their school councils' memberships in ASCA. This is very strong evidence of the commitment of Alberta's school boards to their school councils, the value they see in parents' involvement, and of the voice and influence school councils have at a provincial level. ASCA greatly appreciates this show of support from school boards, as do the school councils who benefit from contributing to the advocacy executed by the Association on their behalf.

In all discussions and decisions, the ASCA Board of Directors strives to be as representative of our members, as our members are of their school communities. As individual Directors, we often have to set aside our personal perspectives and carefully consider what is in the best interests of all of Alberta's students, as we've heard through the voices of our Member School Councils across Alberta.

Our AGM is one of our ways of hearing from you – our members – about provincial-level educational matters. As it isn't likely that we will ever have a representative from all of our 1300+ Member School Councils attend the AGM, the Board embarked upon a new way to engage Members who may not have the ability to attend – through the Proposed Advocacy Resolutions Pre-Vote held in February in March. One hundred eighty nine (189) Member School Councils participated in the Pre-Vote, some of whom are also represented here today in person, some of whom are represented via proxy, and others who may have chosen to limit their involvement to only the Pre-Vote. The Board is very pleased with the first-year success of this process, and looks forward to making it even better for more Member School Councils next year!

Representing our Member's perspectives to Alberta Education, our education partners, stakeholders, and the general community, is a responsibility taken very seriously by your Board of Directors, and the provincial office staff. While the Advocacy Resolution process at our AGM is one way to hear from our Member School Councils, our Board of Directors recognizes that it must utilize a variety of methods to also hear your voices between AGMs. The School Council Engagement Task Force has helped us to do this, as have the efforts of Directors to reach into the community and connect with individual school councils or Councils of School Councils. This very important work of the Board will continue into 2019-2020, along with exploration of other methods the Association can use to hear from you.

#### **Service and Support:**

We are proud of the work our Association does in Alberta, and proud of the work our member school councils do in their local school communities. As a result of funding received from Alberta Education in the form of a Conditional Grant, supporting and guiding school councils to understand and fulfill their legislated purpose in their school communities is a primary focus of ASCA.

Beginning in August, our Client Services team of Instructors and staff have provided on-site services to over 150 groups so far this year; some of them individual school councils, some multi-school council groups like Councils of School Councils and district gatherings, and some specifically to groups of principals, trustees or district administrative teams. Through these on-site deliveries, almost 450 school councils have increased their knowledge and skills in order to support and enhance student learning.

As well as ensuring on-site support is timely and effective, staff in the office have responded to close to 1400 phone calls and emails from individual parents, school council chairs or executive members, principals, trustees, superintendents and parents on school-based fundraising associations. Regardless of the audience, our message is always consistent: *School councils have an important role to fulfill to support and enhance student learning.* 

# **Stewardship of the Association:**

Speaking of important roles, one belonging to your ASCA Board of Directors is to set the direction for the Association, and to ensure that the decisions of the Members and the Board can be acted upon with the processes, skills, tools and resources available to the Association.

The Board of 2018-2019 reviewed and revised the Mission and Vision of the Association, along with the long-term goals – articulated in the 2019-2022 Vision Path.

In addition, an extensive review and revision of the Association's Bylaws took place, for your consideration later this morning. As well, the Board looked at several sections of its Governance Policy Manual, and made changes where it felt they were needed.

Through six (6) very active and dedicated Board Committees, stewardship of the Association was always a top priority for your Board of Directors, and one that will continue to be a priority for 2019-2020.

# **Summary:**

As the education landscape in Alberta continues to change, the Mission and Vision of ASCA will continue to be the banner under which your Board of Directors will persistently move forward. Each and every decision made, and action taken, will reflect the views of our Members, will be intended to support and guide school councils in their communities, and will ensure the long-term relevancy and sustainability of your provincial Association. Thank you — our Member School Councils and the parents, principals, students and others who serve them - for being the reason ASCA is celebrating 90 years, and is looking forward to celebrating 100!

# **ASCA 2019 AGM RULES OF ORDER**

- Robert's Rules of Order Newly Revised shall be the parliamentary authority in all cases <u>not</u> <u>covered</u> by the Bylaws of the Alberta School Councils' Association (ASCA) or these Rules of Order; in particular, in the handling of resolutions and motions.
- 2. Each person attending the Annual General Meeting (AGM) shall register at the Registration Table and is required to wear the Name Badge provided while in attendance at the AGM.
- 3. Voting members are only those Parent Delegates from ASCA member School Councils who have submitted their signed Credential Voting Form prior to or upon registering at the AGM.
- 4. Voting Parent Delegates from member School Councils are required to obtain their Voting Cards, Ballots, and any Proxy Voting Cards and Ballots they may be authorized to carry from the Registration Table.
- 5. Voting by Parent Delegates shall be by Voting Card only.
- 6. Only the Authorized Voting Parent Delegate may present or second a Resolution or main

- motion. After presenting a Resolution, the Authorized Voting Parent delegate may speak, or invite another delegate from his/her school council to speak on his/her behalf, for a maximum of three (3) minutes.
- 7. The Voting Parent Delegate or his/her designate shall have a further two (2) minutes for closing comments.
- 8. Any delegate may speak only once to any motion for a maximum of three (3) minutes.
- Those wishing to speak shall use the microphone(s), take a place in line and, upon being recognized by the Chair, state the name of their school council and its location, and then their full name.
- 10. Upon recognition by the Chair, non-voting delegates may ask questions during discussions or speak to any motion, but they may not introduce motions or vote.
- 11. When time is of the essence, Voting Delegates shall be given priority to speak over non-voting delegates.
- 12. Any amendments or new motions (not already in writing in the AGM package) must be submitted in writing to the Recording Secretary, signed by the mover and seconder if required.
- 13. Procedural Motions, such as the adoption of the Rules of Order, Agenda, and Minutes, the Delegation of Authority to Appoint the Auditor, the closing of Nominations and the Destroying of Ballots, require only a mover.
- 14. Substantive Motions, such as those required for the Resolutions, require a mover and a seconder, and will be so noted on the Agenda where appropriate.
- 15. A Motion to Remove, Sever or Divide a specific Resolution from an Omnibus Motion/Resolution, requires a seconder and must have 50% approval of the Voting Delegates at the AGM in order to stand alone. The mover of the motion to sever may have one (1) minute to explain the reason to sever. If the reason for the Motion to Remove, Sever or Divide a Resolution is stated as being an unclear intention of the Resolution, the Resolution Sponsor may have one (1) minute to provide clarification of the Resolution intention to the assembly, prior to the vote being taken.
- 16. The final wording of Resolution titles and background material, as well as grammatical edits, shall be the responsibility of ASCA staff after the Resolution passes and prior to action being taken.
- 17. In order to be placed on the Order Paper, Emergent Resolutions related to provincial educational situations that have developed or arisen after the deadline for Resolution submissions must be approved to be added to the order paper by 75% of the Voting Delegates at the AGM and must be accompanied by printed copies provided to the Assembly by the sponsor.
- 18. Extraordinary Resolutions arising as a result of the business conducted at the AGM, must be approved to be added to the order paper by 75% of the Voting Delegates at the AGM, with specific wording provided in writing by the sponsor to the Resolutions Chair and Recording Secretary.
- 19. No materials of any kind shall be distributed, sold, or displayed at or during the AGM, and no appeals for support or collections of any kind shall be made, without prior approval of the Alberta School Councils' Association President.
