- On request, advised Minister of Education and Alberta Education staff respecting parent perceptions of current or emerging education issues/trends;

ASCA has been asked to share its strategies and best practices for engaging Elders and Indigenous Leaders in our work, and the work of school councils, at the May meeting.

Terms of Reference for each Committee were approved by the Board. Directors appointed as Lead for their Committee provided regular activity reports and updates to the Board. Committees accomplished their assigned responsibilities, bringing recommendations for actions or decisions as needed to the Board of Directors for approval. The ASCA President and Executive Director are deemed to be ex-officio members of all Committees of the Board, unless otherwise noted.

## Advocacy / Resolutions Committee

Directors: Greta Gerstner, Melissa Smith, Brandi Rai Staff Support: Executive Director

#### Summary:

Following the 2022 AGM and the establishment of the new Advocacy/Resolutions Committee, the new members updated the current Terms of Reference (ToR).

The Advocacy/Resolutions Committee was responsible for compiling the themes and questions for the School Council Engagement Task Force. The responses to these surveys contribute to the information used by ASCA to advocate on behalf of Member School Councils and the parent voice.

The Advocacy/Resolutions Committee reviewed current ASCA Advocacy Policies that have reached the tenthanniversary date for continued relevancy. The Committee recommended that Policy 13-3, Installation of Speed Monitoring Devices for Schools, be presented to ASCA Member School Councils at the 2023 Annual General Meeting to be maintained.

Based on what the Advocacy/Resolutions Committee has heard through communications with school councils across Alberta, the Committee prepared three Board sponsored Proposed Advocacy Resolutions for consideration at the 2023 AGM. (Add Rights of Victims of Bullying and Violence to Education Act; Required Consultation Opportunities; Meeting Mental Health Support Recommended Ratios).

The Advocacy/ Resolutions Committee reviewed and recommended revisions to ASCA's existing PAR submission processes and documents, to assist Member School Councils in writing and submitting Proposed Advocacy Resolutions.

The Advocacy/Resolutions Committee assessed incoming Proposed Advocacy Resolutions (PARs) and assisted Member School Councils in ensuring that the intent of the PARs falls within the parameters of ASCA's foundational documents. The Committee is grateful to all Member School Councils who submitted PARs for the Members to consider and discuss at the Annual General Meeting.

#### **Fund Development Committee**

Directors: Greta Gerstner, Krista Li, Andi McDonald (formerly Romito), Kerry Bodell, Brandi Rai Staff Support: Executive Director

#### Summary:

In the June board meeting, the Board approved the establishment of a Fund Development Committee so that the Association can explore/raise alternative funding to realize additional revenue. The Terms of Reference for the committee were created on June 17, 2022, and approved via email vote on June 21, 2022.

Director McDonald led the committee in July in an exercise called mapping to figure out how much we needed to fundraise to meet our financial goals this year and how we can achieve it. Director McDonald and ASCA's contracted Communications Specialist created the Case for Support with input from the Committee to distribute to potential donors.



The committee also submitted a grant proposal for \$5000 to Saskatchewan Mutual Insurance Company (SMI) through Dyberg Insurance Group Inc. to develop Diversity, Equity, and Inclusion (DEI) programming for school communities that reflects the diversity of Alberta. This was unfortunately not successful.

In the August board meeting the Board approved holding an Online Silent Auction with the hopes of raising \$10,000. The months of September, October and November were spent soliciting items for the auction, setting up the auction in 32 Auctions website, collection of items, advertising, and the arrangements for the pick-up of items for successful bidders. The Board, staff, and one volunteer parent from Southern Alberta asked 374 businesses/organizations/school boards/people and received a total of 106 items which helped us raise \$9417.90 through the auction. After direct expenses were paid, the total revenue for the Association was \$9156.

ASCA has a new online fundraising and donor management platform that it will be using from Zeffy to help with Donor Management records. Although the Executive Director has applied through the Canadian Community Services Recovery Fund grant for funds to train and assign a part-time staff position to manage this for a year, for the foreseeable future this may be a shared responsibility of the Fund Development Committee and ASCA administration if the grant application is not successful.

The Fund Development Committee will need to continue next year to find ways to diversify our streams of revenue to ensure the financial viability of the organization. It as not able to explore all the different organizations who align with ASCA to approach for a donation or sponsorship opportunities due to lack of capacity.

#### **Governance Committee**

#### Summary:

The Governance Committee was responsible for recommending for approval of the Board, and completing once approved, amendments to the Governance Policy Manual. The recommendations approved were the amendment of GP 2.C – Role of the Board of Directors to establish processes and provide opportunities for membership input, and GP 13 – Whistleblower Policy to provide clarity regarding the concerns and complaint process.

The Committee also worked on proposing amendments for ASCA Member School Councils consideration to bylaws 3.19, 3.24, 3.42, and 4.2 to reflect the change from the School Act to the Education Act in 2018 and to incorporate results from the member survey conducted in the Fall of 2021. The Committee also proposed amendments to bylaw 6.2 to acknowledge acclamations as an alternative to casting secret ballot votes at General Meetings when actual elections are not needed due to the number of nominations received for relevant positions. These proposed amendments will be presented to ASCA Member School Councils as a Special Resolution at the 2023 AGM.

The Board adopted a consent agenda this year to help with time management so it could spend more time on items that needed more discussion and consideration.

The Governance Committee was unable to complete its task list due to a lack of capacity among Committee members. The Committee leaves the following tasks for the 2023/2024 Governance Committee to consider in its work plan: GP 3 – App 3, GP 4 d/e, GP 7.



## **Internal Financial Committee (IFC)**

#### Summary:

The Internal Finance Committee (IFC) met to review the Terms of Reference (ToR) of the Committee. The ToR was approved at the June 2022 Board meeting with no changes made.

Detailed financial updates were presented by management at each board meeting in the form of an Income Statement and Balance Sheet. Information included Budget, Year to Date Actuals and an estimated Year End Forecast. The Committee ensured insurance/liability coverage, Society Annual Return filing, CRA Charity Return filing and ensured that the Board is fulfilling its fiduciary responsibility and that administrative financial procedures comply with non-profit best practices.

The IFC supported the forming of the Fund Development Committee. A SWOT analysis was not done by the Board this year. The Fund Development Committee performed a needs analysis, which was reviewed and updated on an ongoing basis.

## Legacy Committee

#### Summary:

Following the 2022 AGM and establishing the new composition of the Legacy Committee, it met with ASCA Executive members to review the Terms of Reference (ToR) of the Committee. The ToR was approved at the June 2022 Board meeting with no changes made.

The Committee was not able to undertake any ongoing planning or activities this year, resulting from Director and staff capacity constraints.

While the 100<sup>th</sup> Anniversary of ASCA may seem to still be a few years away (2029), it is recognized that those 6 years will pass more quickly than perhaps anticipated. To prevent Director and staff stress and burnout as 2029 approaches, it is recommended that manageable effort in preparing for and planning the 100 Years recognition and celebration be consistently applied moving forward.

#### Member Engagement Committee (MEC)

#### Summary:

Following the 2022 AGM and the establishment of the new Member Engagement Committee, the new members updated the current terms of reference (ToR).

The Committee continues to perceive the cyclical nature of school councils as a challenge for member engagement and understanding of the work ASCA does. The Committee discussed options for engaging with Councils of School Councils (CoSCs) in the future and identifying ways to engage with administrators to enhance their understanding of the role of school councils.

The Committee was satisfied with the ongoing work of the Association to engage our membership. ASCA offered numerous engagement opportunities, including workshops and training, the ASCA School Council Engagement Opportunity in November, and the UCP Leadership Candidates' forum.

The Committee did not identify a need for or direct additional resources to Member Engagement. We look forward to the upcoming engagement opportunities the conference and AGM will provide.



Due to Directors and ASCA staff capacity over the past year, the Association did not attend as many CoSC meetings as it would have liked, nor directly engage with Member School Councils beyond what was offered through ASCA's Learning Opportunities. The incoming committee members may wish to consider this in the future.

#### **Nominations Committee**

#### Summary:

Following the 2022 AGM and establishing the new composition of the Nominations Committee, it met to review the Terms of Reference (ToR) of the Committee. The ToR was approved at the June 2022 Board meeting with no changes made.

The Nominations Committee also met to review and revise existing nominations documents for the purposes of improvement and enhancement. The Committee recommended and reviewed updates to the Candidates Questionnaire, the Nomination Form, and the Information Package for a position on the ASCA Board of Directors

for use starting in 2023.

The Committee also reviewed all Nomination Forms and Candidate Questionnaires as they were received from parents on ASCA Member School Councils, prior to their posting on the ASCA website.

#### **Recognition Awards Committee (RAC)**

#### Summary:

The Recognition Awards Committee is a standing committee that chooses recipients for awards recognizing the contributions of Member School Councils, Parents, Learning Partners, Districts and other ASCA supporters.

The Committee met once to review the Terms of Reference (ToR) of the Committee. The ToR was approved at the June 2022 Board meeting.

When the Board reviewed and approved the 2022-2025 Vision Path, Priority 2 of Destination 2 was revised to reflect the financial realities of the Association, and its inability to continue the recognition program that had previously been in place.

Due to this lack of financial resources, all work related to this Committee continues to be suspended indefinitely.

The 2023-24 Board of Directors needs to consider if there are sufficient resources to resume the work of this Committee.
