I. Education Issues and E-Scan

1) UCP Leadership Candidates Forum – September 26th, 2022

The President explained the change of date and reminded Directors to register for the event. There are five (5) UCP Leadership Candidates confirmed to attend. The questions received by registrants have been themed and distributed to those candidates.

- 2) Stand for Education Campaign President Rai spoke to the campaign's intention and positive, forward-focused theme.
- 3) October 22nd Rally for Public Education This family-friendly event is intended to raise education awareness ahead of the May 2023 provincial election.

Roundtable: Items Identified by Directors:

Local ATA rep attending school council meetings to bring awareness to the campaign and rally. A new Indigenous consultant in the division is very present; More Indigenous gatherings are being planned in the school division.



Welcome Back and Meet the Teacher events in schools are providing opportunities to encourage school council education and engagement.

The New Chair role with a new principal provides the opportunity to change the culture and focus of the school council to include enhanced engagement.

Significant administrators shift in a division creates challenges and opportunities, including some for promoting ASCA training for administrators.

The Mental Health Grant offered by Alberta Education with the application deadline of September 15th has created challenges for some schools.

CoSC meeting discussions included how the role of school councils does not include fundraising; access to the ASCA Members Only section, ASCE Grant.

Considerable concern for the lack of infrastructure funds – more schools needed in the division – causing students to switch systems to access closer options.

Increases in school fees create stress for many families, and some schools need to subsidize or write off the fees.

The strained relationship between school councils and fundraising associations is causing hard feelings and disengagement of previously integral leaders.

The school community is not acknowledging contributions made by parents/school council in previous years.

There is a perception in some school communities that school councils are being utilized to advance personal agendas without appropriate broad engagement.

Some divisions are experiencing a significant bus driver shortage, resulting in students being late to school due to buses having to do more than one route. The frustration of parents is high, especially with increases in transportation fees.
