I. Education Issues and E-Scan

Roundtable - Items identified by Directors:

Feedback from CoSC meeting included brief ASCA update and request to district for support in sending school council parents to ASCA Conference. Discussions about restricting schools/grade configuration to address low enrolment issues. Hearing that resources for the current curriculum aren't as robust as desired, and the subjects that are currently being piloted are needing some refinement. Heightened awareness of anti-racism groups online, attracting vulnerable youth to engage in inappropriate activities. Ward Trustee invited schools/school councils to a town hall meeting to discuss concerns (engagement, traffic and safety, diversity and inclusion, food insecurity). Trustee for neighbouring Ward hosting a School Council Leaders event focused on mental health, wellbeing, hopeful vision, engagement, Social Stride. Utilization of the ASCE Grant has been frustrating, and time consuming. Future location of high school is still concerning. Restructuring and school board rezoning within the division to address enrolment issues is resulting in some families traveling extreme distances to dedicated schools. Some students are acting aggressively towards students with family in European countries engaged in wars. Dysregulation levels are extraordinarily high in children and adults. Food insecurity is a concern for many families. Parents on school councils and fundraising associations are being asked to contribute, solicit donations, provide items. ASCA Executive met with Minister LaGrange to represent the perspectives of ASCA Members. Topics covered included concerns related to classrooms not being well supported, student needs not being met, with explanations from schools and divisions defaulting to 'no money', despite healthy reserves/surpluses.
