must account with clear standardization of school board budgeting for districts. While the previous funding model wasn't perfect, it allowed for adequate planning annually.

 - In 2021 I ran for a position as trustee for RDPSD school board. I heard many diverse perspectives, some of which aligned with mine, some of which were quite opposing. I approached every conversation with an attitude of respect with the same expectation in return; by setting this expectation up front, I was able to have authentic conversations that were (mostly) positive experiences and learn from those I engaged with.
