April 8	Preserving Choice for Children and Youth: ABEd Parent Engagement – Virtual	S. Odishaw	Attended by Alberta Education ADM and staff, and parents from across Alberta. Breakout groups discussed the below topics with outcomes shared with the group as a whole. All of these topics will affect students, parents and school councils. At the time of this engagement, ASCA had a number of Proposed Advocacy Resolutions supporting the 2SLGBTQIA+ community. The conversation(s) during the engagement showed little support for these changes and much support for the PARs to be discussed at AGM. • Parental notification of student requests for name change

April 8	Alberta Regional Professional Development Consortia (ARPDC) Focus Group	W. Keiver	Participants reviewed results from the ARPDC Assurance Survey, and provided feedback and perspectives related to same, and to improving practices across all Consortia.
April 12	Preserving Choice for Children and Youth: ABEd Parent Engagement – Edmonton in Person	B. Rai	Parent representatives met with Alberta Education staff for three hours and were led through discussions related to proposed policy changes. These changes included restricting students from using preferred pronouns without parent notification and/or consent based on age of student. Changes also discussed limiting resources for teacher use related to health curriculum/ 2SLGTBQIA/ sexual orientation/gender identity materials to those resources approved by the Ministry of Education. Also, discussions were held related to parents needing to opt in for their students to learn/participate in lessons related to sexual orientation and gender identity, which is one of the proposed policy changes. The changes proposed related to restricting trans girls from playing sports with girls, as well as a proposed pilot counseling project for trans students were also discussed. Overall, many of these policy changes were considered unnecessary by the parents in this engagement session. The staff from Alberta Education stated the scope of the session was related to the implementation of these policies, irrespective of the feedback that generally stated that each of these policies did not support students, parents, or school communities. The out-of-scope comments from the group would still be passed to the Ministry though, according to Alberta Education staff.
April 15	Honouring Spirit Indigenous Student Awards	B. Rai K. Bodell	Attended by the students and families being honoured, representatives from ASBA, ASCA, GOA, and other stakeholders. It was an honor to be able to participate in the selection committee process again. Reading the nomination packages and seeing all the good being done in communities



			across our province by students is inspiring and affirming. Attending the Awards ceremony was beautiful as each selected recipient received a blanket, a certificate, and a grant.
April 23	Engagement on Cell Phone use in Schools (ABEd)	W. Keiver	Attended by representatives from: ATA, ASCA, ASBA, AISCA, CASS, TAAPCS, and possibly others. Participants were asked to provide their perspectives on the idea of the GoA establishing provincial policies, expectations, or guidelines for cell phone usage in school. In general, associations represented stated that while their specific association did not have a 'position' on this topic, it was acknowledged that school authorities, schools, and even some teachers were already implementing rules and expectations. One association present did support the idea of a provincial policy. ASCA advocated for broad parent consultation, at local, division, and provincial levels, to ensure that what was either happening or being contemplated, aligned with parents' expectations.

			P24-03 Improved Indoor Air Quality (IAQ) in Alberta Classrooms & Shared Environments: Minister mentioned the Capital Maintenance and Renewal funding. They are committed to making sure there are funds set aside for this. There is money in Board budgets and it is up to the Boards to allocate specific funds for HVAC.
			P24-06 Resource Support for French Immersion Teachers: work on promoting the new Alberta site. There is funding set aside for curriculum materials, including French. They are currently working on developing more resources for the 2024-2025 school year. The Ministry and ASCA are going to find a way to work together to bring awareness to how/where to access French resources.
			ER24-02 Preserve Non-Partisan Elections for Alberta School Board Trustees: Minster mentioned that there were some amendments. It was mentioned that there is more work to be done on the policy and that Municipal Affairs is having additional conversations with Boards and that the conversation is still open. Wording included that it's not that they MUST be affiliated but that they CAN be affiliated with a political party and that the political party they can be affiliated with is not one of the existing provincial parties. We have requested further information in writing from the Minister.
			A future meeting to discuss policies within P24-05 and ER24-01 was requested by ASCA.

The MYC meets 3 times per year over weekends, and there are 40 students on MYC each year, with an average of 8 staying on for a second year each year. Teacher Retention Crisis: 1 in 3 Alberta teachers are considering leaving, relocating, or early retirement due to professional challenges (per Dr. Phil McRae). Aligning Generative AI, Ethics, and Teachers' Values Concerns around cheating, AI policy alignment, and assessment integrity. Ethical discussions dominate over practical AI use, limiting teachers' ability to engage with the technology effectively. Exploring Social Emotional Wellness PEAKS (Place-based Experiences Adventures and Knowledge for Students): Focus on place-conscious pedagogy and social-emotional learning (SEL). Broader discussion on education across Canada.

ASCA School Council Engagement Task Force (SCETF) 2024-2025

The 2024-2025 Board of Directors opted to pause the ASCA School Council Engagement Task Force (SCEFT) for this year. Discussions will take place with the new ASCA Board as to the viability and value of the SCETF in the 2025-2026 school year.

ASCA Board 2025-2026 Committees

To strengthen ASCA's governance and operations, the Board streamlined its eight standing committees into three functional committees: Internal, External, and Fund Development. This restructuring has enhanced our ability to be more agile, focused, and effective. With this foundation in place, we continue working to ensure that ASCA remains a strong, sustainable organization dedicated to serving school councils across Alberta.

Terms of Reference for each Committee were approved by the Board. Directors appointed as Committee Leads provided regular activity reports and updates to the Board. Committees worked to accomplish their assigned responsibilities, bringing recommendations for actions or decisions as needed to the Board of Directors for approval. The ASCA President and Executive Director are deemed to be ex-officio members of all Committees of the Board, unless otherwise noted.

The ASCA Board Committees on which the 2024-2025 ASCA Board of Directors served were:

External Committee

Summary:

Following the 2024 AGM and the establishment of the new External Committee, the new members updated the current Terms of Reference (ToR).

The 2024-2025 External Committee was responsible for:

- * Reviewing/Revising the ASCA Candidates Information Package and Nominations Form.
- * Assessing existing ASCA Advocacy Policies approaching their tenth anniversary for continued relevance, recommending to the membership whether to archive, amend/revise, or maintain them.
- * Reviewing incoming Proposed Advocacy Resolutions (PARs), ensuring they aligned with ASCA's foundational documents. The Committee applauds Member School Councils for submitting PARs for debate at the Annual General Meeting.
- *Reviewing ASCA's Recognition Awards criteria and nominations, selecting successful candidates, arranging for Award deliveries to local school communities.

Despite their efforts, the committee was unable to complete all tasks, as a result, they pass on the task of restructuring the School Council Engagement Task Force (SCETF) for better information gathering to the 2025/2026 Committee.

Fund Development Committee (FDC)

Directors: Edward Tse, Meagan Parisian Staff Support: Executive Director

Summary:

This year, the Fund Development Committee focused on one urgent goal: to make it easier for school councils to get more value from their Alberta School Council Engagement (ASCE) grant and to ensure ASCA has predictable and sustainable long-term funding to support School Councils across Alberta.

We started by asking School Councils how things were going with the ASCE Grant. The results of our province-wide survey were honest—and deeply revealing. Many councils said the grant was hard to use. They didn't know



what was eligible. They couldn't find affordable speakers. Some didn't even know the grant existed. Even when sessions were planned, attendance was often low and impact felt uncertain. New council chairs in particular asked for help navigating what to do.

Quantitative responses from School Councils across Alberta reinforced the qualitative results:

22% were unaware of the ASCE grant entirely

Only 62% had used their ASCE grant in previous years

Many councils described the grant as confusing, overly restricted, or burdensome to manage Councils specifically asked for vetted speaker lists, clearer planning tools, and more ideas on how to use the grant effectively

In response, we created the **ASCA Access Pass**, launching September 2025.

The **ASCA Access Pass** is a program that allows school councils to **use their existing ASCE Grant** to register for a full year of:

Monthly live learning sessions with expert speakers
Breakout discussions that allow parents to connect across Alberta
Recorded sessions accessible to every parent in the school
Topics chosen twice a year by school councils themselves

It's still your ASCE grant—but the ASCA Access Pass removes the guesswork.

We reviewed every ASCE Grant requirement and created:

A grant application email template to send to school boards

A **year-end reporting template** with sample language

Guidance on ASCE Grant eligibility

While school councils still need to apply for and report on their own grants, the ASCA Access Pass significantly reduces the time and effort needed—especially for new or busy councils.

To ensure ASCA can continue delivering this support year after year, we developed **sponsorship programs** for companies and speakers that directly benefit member school councils. New sponsors help cover the cost of delivering the ASCA Access Pass—**keeping it fully grant-funded for councils**. This new revenue stream helps protect ASCA from funding uncertainty and allows us to keep investing in high-quality parent learning, tools, and advocacy.

Every part of this year's work came from what school councils told us they needed:

- Easier access to quality learning
- Less time spent chasing speakers or filling forms
- More ways to bring value to their school communities
- A stronger ASCA to advocate on their behalf

The ASCA Access Pass was built to make it easier for School Councils to get more value from the ASCE grant so that ASCA can continue to be the strongest collective voice for parents in Alberta.

Internal Committee

Summary:

The Internal Committee was responsible for the Governance Policy Manual, Internal Finance and Legacy. At our June meeting we recommended the Board approve our Terms of Reference.



This year for the Governance Policy Manual, the Committee updated and recommended the Board approve amendments or revisions of the following Governance Policies:

- GP-2 the Role of the Board
- GP-3 the Role of the Director
- GP-8 Board Committees
- GP-12 Role of the Executive Director
- Related appendices for GP-2, GP-3, GP-8 and GP-12

At the direction of the Board, the Committee also created GP-3-App 3E – ASCA Social Media Presence, Management and ASCA Brand Stewardship which received Board approval.

The Committee also recommended deleting GP7-App 7D – Care and Use of Director's Technology Equipment Agreement as it was no longer relevant.

The responsibilities for Internal Finance included ensuring the following:

- The Trustee/Non-Trustee Accident Policy which covers the Board, Instructors and the Executive Director was renewed on September 1.
- The D&O, Cyber, Commercial Insurance policy renewed on November 1.
- The Society Annual Return was submitted on April 30, 2024, and the Proof of Filing was received.
- A Change of Directors was submitted on September 30, 2024, removing Directors Haggarty and Bruce and President Bodell. Proof of Filing for the Change of Directors was received.
- The Annual Return (T3010) was submitted to CRA by our auditor. The Confirmation/Notice of Receipt was received from Canada Revenue Agency.

Activities that were undertaken related to Legacy were:

- Former President Bodell, Past President Rai, Executive Director Keiver and the Committee Lead met at
 the ASCA office to go through all the boxes that contained ASCA related materials. We separated the
 materials into boxes for AGM Minutes and past Advocacy Policies. There is also a box of items that could
 be used for future Legacy displays.
- The Committee Lead has uploaded in Teams, under Internal Committee, 2024-2025 Board Meetings, a
 folder labelled "Advocacy Policies 1960-1994" as a start of scanning all the advocacy policies that are not
 currently housed in the archived section at the back of our Advocacy Policy Manual that were found in
 the boxes. There were several dates missing for this time frame in the documents that were scanned
 and uploaded from the one box. There are currently 3 boxes of documents that still need to be scanned
 in.

The Committee was not able to review our Bylaws and Governance Policy Manual to consider the expectations, accountability, and consequences of ASCA Member conduct and develop related guidelines and processes as our capacity was limited.

We also were not able to create the ASCA Origin Story so that the history of ASCA and how our organization has evolved over the years could be documented in an easy-to-read story.
